Every individual has the right to live free from violence or the threat of violence. We help our clients navigate the legal system dealing with restraining orders and court ordered visitation. We provide no cost counseling and peer group counseling to help create a healthy, happy future for their family. Our staff is committed to providing a structured, yet compassionate environment for victims of domestic violence in need.

Our 24-bed facility serves victims of domestic violence who are female, male, and LGBTQ. While in the shelter, victims can remain together with their children and pets in a safe nurturing environment while they negotiate this painful transition in their lives. Hope House also provides transitional housing to keep supporting the client along the journey to independence.

We strive to:

- Provide shelter services and transitional housing assistance for victims of domestic violence
- Provide an intensive program to help clients make better decisions
- Help clients identify permanent and healthy solutions
- Provide safe place for clients, their children, and their pets
- Provide the tools needed for clients to grow and become productive members of the community

Anti-Human Trafficking Program



The Open Door provides case management and support to all victims of human trafficking and sexual exploitation. Our mentors and advocates support these victims through the legal system and assist them with accessing resources to overcome the trauma they have endured and advance from life on the street.

Clients are referred to our care through strong partnerships with Public Defenders, District Attorneys, Children and Family Services, local school districts, and the California Department of Probation. We are pleased to announce that although most clients relapse and find themselves "back in the life," we have a near 100% success rate with those we continue working with. Our door is always open and most clients return.

We believe in engaging community members in bringing awareness on the issue of sex trafficking in our communities to reduce stigma towards victims and survivors. We are a team committed to assisting participants in reunifying survivors with their families, when applicable, advocating on their behalf, to helping survivors build a foundation for a solid future, and to fostering growth in each of our participants.

Re-Entry Program



Next Step is an empowerment program that helps to develop a healthy mindset for re-entry back into society for those on parole and probation. Support services empower men and women on probation and parole to find strength, stability, and success.

We provide housing, case management, and counseling in the High Desert, San Bernardino, and Morongo Basin areas for men, women, and their children. These services are provided to the client for up to one year.

The Next Step program accepts parolees and provides resources and housing assistance. A Case Manager will meet with those detained and helps to plan for their release. They will assist with their personal goals and essential needs for a healthy way of living. The program will provide basic necessities like food, clothing, and transportation. Many different classes are provided for personal development and continued education to develop the client into a productive member of society.
